This Field Service Instruction provides guidance for reworking the Kodiak 100 battery box to increase fatigue life.

The instructions contained within are applicable to all aircraft with the vertical firewall stiffener 100-210-1005-D01 and 100-210-1005-D02 installed (Production Serial Numbers 100-001 through 100-0068).

3. Component Removal

3.1 Fuel Selectors

Turn the overhead fuel selectors to the "OFF" position.

3.2 Master Switch

Turn the master switch to the "OFF" position.

3.3 Engine Cowlings

Remove all engine cowlings in accordance with the KODIAK 100 Maintenance Manual, Chapter 71 "Power Plant".

3.4 Batteries

Remove both batteries in accordance with the KODIAK 100 Maintenance Manual, Chapter 24 "Electrical Power".

3.5 Fuel Pressure Transducer

Remove the fuel pressure transducer from the aircraft by completing the following.

3.5.1 Electrical Connection

Disconnect the electrical connection from the fuel pressure transducer.

3.5.2 Fuel Lines

Disconnect the fuel lines at the firewall fuel filter. Cap both open ends.

3.5.3 Clamps

Loosen the cushioned loop clamps and remove the fuel pressure transducer from the aircraft.

3.6 EPA Lines

Disconnect the EPA can lines as needed in order to remove the left battery box.

3.7 Electrical Relays

Disconnect the electrical relays connected to the right battery box.

3.8 Battery Boxes

Loosen and remove the six (6) bolts and six (6) washers securing each of the battery boxes to the firewall, and remove the two (2) battery boxes from the aircraft.



3.9 Mount Brackets




Figure 3-1: Drill-Down for Fastener Removal

Drill out the five (5) fasteners securing each of the aluminum battery box mounting brackets (P/N 100-210-1027) to the firewall; refer to Figure 3-1. Remove and discard the mounting brackets.

3.10 Nut Plates

Drill out the two (2) fasteners securing each nut plate to the stainless steel firewall stiffener; refer to **Figure 3-1**. Remove and discard the nut plates.

4. Battery Box Installation

4.1 Backup Plate




Figure 4-1: Battery Box Bracket Installation

Position and secure the backup plate (P/N 100-210-1034) and three (3) nut plates (P/N MS21047L3) using six (6) MS20426AD3-4 fasteners; refer to Figure 4-1. This installation is mirrored on the opposite side of the aircraft.

4.2 Angle Bracket

Position and secure the aluminum angle bracket (P/N 100-210-1033) using five (5) MS20615-3MP3.5 fasteners; refer to Figure 4-1. This installation is mirrored on the opposite side of the aircraft.

4.3 Backplate




Figure 4-2: Backplate Installation

Position the backplate (P/N 100-124-2107), ensuring that the radius on the backplate is facing toward the mating flange. Secure using two (2) MS20426AD3-4.5 fasteners; refer to Figure 4-2. This installation is mirrored on the opposite side of the aircraft.

5. Component Reinstallation

5.1 Battery Box

Position and secure the battery box using six (6) new bolts (P/N AN3-4A) and the six (6) existing washers removed in **Section 3.8**; perform this effort for each side of the aircraft. Torque all bolts to 20-25 in-lb.

5.2 Electrical Relays

Reconnect the electrical relays to the right battery box.

5.3 EPA Lines

Reconnect the EPA can lines to the left battery box.

5.4 Fuel Pressure Transducer

Reinstall the fuel pressure transducer to the right battery box.

5.5 Batteries

Reinstall both batteries in accordance with the KODIAK 100 Maintenance Manual, Chapter 24 "Electrical Power."

5.6 Engine Cowlings

Reinstall the engine cowlings in accordance with the KODIAK 100 Maintenance Manual, Chapter 71 "Power Plant."

6. Record of Completion

Upon completion, record all work performed in the appropriate *KODIAK 100 Maintenance Log Book*.
